Prior to joining Summit County Juvenile Court, she served as an assistant prosecuting attorney at the Summit County Prosecutor's Office and a criminal defense attorney for the Legal Defenders Office of Summit County.

Magistrate Walls-Alexander has the character, education, experience needed to serve all who come into contact with the Summit County juvenile justice system.

# SCJC Employee Jimmy Oliver Inducted into the Summit County Sports Hall of Fame

The game of basketball has taken Jimmy Oliver across the globe. On October 4th, Oliver's achievements in the game were celebrated in his adopted home. The Summit County Sports Hall of Fame enshrined Oliver with eight others who have excelled as an athlete or provided service to athletics in Summit County.

Oliver is a native of Menifee, Arkansas, one of six children. His skill on the court at Morriton High School saw him named Mr. Basketball of Arkansas and he caught the attention of major colleges throughout the country. However, Oliver accepted a scholarship at Purdue University.

Oliver spent three seasons playing a shooting guard and a small forward on the Boilermakers' squad. It


was during his junior season that he began to emerge as a viable Big Ten Conference player, averaging eight points a game while shooting 50% from the field. He helped Purdue to a 22-8 season and a berth in the NCAA Tournament where Purdue advanced to the second round.

His senior year, Oliver elevated his game to a new level. He averaged almost twenty points per game, shot 40% from 3-point range, and led his team in assists. His performance earned Oliver first team All-Big Ten honors. Again, he led Purdue to the NCAA Tournament.

The Cleveland Cavaliers selected him in the second round of the NBA Draft. It was the beginning of a professional basketball career that saw him play for five NBA teams and sixteen teams in the Continental Basketball Association and overseas.


Oliver played for several teams in Europe, and he was a pivotal player on teams that won the Copa Galicia championship, the FIBA Saporta Cup championship where he was named the tournament's Most Valuable Player Award, the Slovenian League championship, the Slovenian Cup winner, and Slovenian Super Cup winner.

When his career ended, he settled in Summit County, where he



has lived for the last 21 years.

He majored in sociology at Purdue and knew, in his second career, he wanted to work with

"Athletics always throws challenges at you. Problem-solving is a big part of being an athlete; seeking ways to improve," he said. "I can apply that experience to the people I work with. I encourage them to solve problems, to find solutions, to look at every option and pursue it."

#### **Veterans**

### Veterans Resource Case Manager Hired to Promote Positive Outcomes in Child Welfare Cases

One of the primary goals of the Summit County Juvenile Court is to investigate every method possible to keep a family intact. However, there are times when circumstances prevent that. It is then that the Court reverts to addressing the issues that separated the family and introduces programming aimed to re-unify the family.

Summit County Juvenile Court has implemented programs, such as the Family Reunification through Recovery Court and the Multidisciplinary Representation Team, that work with a particular demographic and provide guidance and assistance to overcome the issues that led to losing custody of their children.

In mid-October, the Summit County Juvenile Court became the first juvenile court in Ohio to focus on another demographic: veterans.

Andrew Cox, an 18-year Air Force veteran, was hired as the Court's Veteran's Resource Case Manager. His job will be to work with veterans who become Court-involved and are facing custody issues.

"There have been several cases that have come before me and our Magistrates when parents note their military service," said Judge Linda Tucci Teodosio. "I felt we had to do a better job of screening parents who have a military background and finding suitable benefits to help them."

There is a healthy infrastructure of organizations that aid veterans in Summit County and Cox will network with those organizations to access grants, counseling, and other benefits for those parents who are referred to him. He will help guide them through the process of obtaining aid that is uniquely designed for veterans. Cox will develop individual case plans for each person with the ultimate goal of reunification with their family.

"I struggled when I transitioned from the Air Force to private life," noted Cox. "I can say without hesitation that the support and advice I received from veteran's organizations in the community was significant, and I believe I can call on my experience to assist those who might need those same benefits."

Cox will also work with relatives who have taken temporary custody of children and link them with the necessary resources should they need them. Accessing mentoring, support and spousal groups, and transportation for veterans on his case load will also be part of Cox's job.

One of the local organizations that provide those facets of aid to

former members of the military is Warriors Journey Home. Its founder, Rev. John Schluep, feels the hiring of Cox is a positive step forward.

"Summit County Juvenile Court Veteran's Resource Case Manager will be a true asset in providing veterans' earned services and support. Serving veterans means serving the veteran's family. A program that recognizes and addresses those issues and needs help bring veterans home," said Rev. Schluep. "Coming home requires adjustments not only for veterans but their families. It's not solely the veteran's responsibility. That is why I am grateful to Judge Teodosio and Andrew for putting a program in place where the needs and resources can be determined and attained."

Another responsibility for Cox will be providing counsel to court-involved youth. Judge Teodosio noted that often a youth will infer that he or she is interested in joining the military. Cox will be able to provide advice and insight as to what branch of the military might be the most suitable for the youth.

"Beyond his vast experience as a veteran, Andrew brings an enthusiasm for this job that I could sense when I met him," said Judge Teodosio. "He has a genuine desire to help his fellow veterans leverage resources and, most importantly, help them reunite with their families."

flowerscaped garden is located at 650 Dan Street in Akron, Ohio. The site is annually prepared, planted, and maintained by court-involved youth participating in the Child Responsibility Project.

The Child Responsibility Project provides juvenile offenders with meaningful work experience while holding them accountable for their delinquent acts that result in property damage, property loss or personal injury. By performing community service activities at an hourly wage (under the supervision of a court employee), project participants pay restitution (\$1,000 maximum, per case) to the victim of their offense.

## SCJC Employee Bruce Alexander Inducted into the Akron Public Schools Athletics Hall of Fame

On Saturday, October 1, 2022, Bruce Alexander, a probation case manager at Summit County Juvenile Court, was inducted into the Akron Public Schools Athletics Hall of Fame.

Alexander, a proud graduate of Akron North High School, was an outstanding student-athlete who excelled in basketball. So much so, he was named Akron Beacon Journal Player of the Year in 1978.



After graduation, Alexander attended Youngstown State University. As a penguin, he scored 1,480 points and became the 18th player in Youngstown State University history to score over 1000+ points. In honor of this achievement, Alexander was inducted into the Youngstown State University Athletics Hall of Fame in 1994.

Off the basketball court, Alexander found professional success serving the citizens of Summit County. In addition to his tenure at Summit County Juvenile Court, Alexander has served as a member of the Akron Public School Board since 2009.
